Regulations, Licenses, and Permits

Several management activities are regulated by the Wisconsin DNR. For example, to **LEGALLY APPLY** algaecides or herbicides requires a license or permit. If it is professionally applied, the applicator is required to hold the proper licenses as well. Obtaining the correct license and permit can seem confusing, but in reality it is very simple and we offer assistance with this process.

For most existing ponds, the two activities that require permits or licenses are fish stocking/removal and algaecide/herbicide applications.

Other Considerations

Ask specific questions about the pond and obtain as much information as possible. Information should include past management efforts, stocking records, problematic areas, etc. Obtain information regarding the construction of the pond such as initial depth, shoreline protection, equipment in place (aeration/fountains), water source, and intended size. If that information is not available you may want to hire a professional to evaluate the pond. Management requirements are often directly related to the structural stability of the pond.



<u>Costs</u>

Management costs are highly variable for each pond and for each owner. Based on our experience, a ½ acre pond can cost as little as \$500/year. Factors to consider are management objectives, overall pond condition, and the individual(s) performing the maintenance. Successful pond management programs always include a management PLAN, an established BUDGET, and a set SCHEDULE.



Integrated Pond Management

IPM programs are really considered "hands-free" management for the customer. A professional will develop a management plan defining specific parameters including monitoring schedules. Preventative maintenance tools are utilized focusing on water quality improvements, reduction of algaecide/herbicide use, and enhancing aesthetics. IPM is very popular with clients that demand the best from their pond, but do not have the time to perform the maintenance themselves.
